Clemson Rural Health Clinic in Orangeburg

The Clemson Rural Health team is continuing to expand across the state of South Carolina and coming to the Orangeburg region. Clemson Rural Health is the organizing framework for Clemson's health service delivery and prevention efforts statewide and seeks to reduce preventable hospitalization, premature death, and enhance health behaviors. Clemson Rural Health is comprised of a unique, interprofessional team focused on primary care and prevention to underserved and rural communities across South Carolina, including on campus at Clemson University. We operate brick and mortar clinic sites, a fleet of mobile health units, and virtual clinic visits in the delivery of this mission while training future health professions through hands-on student learning experiences.

Through a strategic collaboration with Regional Medical Center Orangeburg, the Clemson Health Clinic at Orangeburg will open this fall to serve the residents of Orangeburg, Bamberg, Barnwell and Calhoun County. The clinic will serve as a hub for mobile and virtual chronic health care management. To fulfill the mission of this expansion, we are hiring for several critical positions. The Mobile Health Coordinator is responsible for coordinating efforts of the mobile health unit and team, while delivering evidence based, lifestyle education using appropriate technology platforms to patients in rural South Carolina. Primary driver/operator of the mobile health unit. Performs other duties as assigned.

Job Duties:

35% - Essential - Mobile Health Unit Coordinator/Operator:

Ensures readiness of mobile health unit vehicle(s) for outreach activities. Coordinates maintenance of mobile units with office manager, ensuring appropriate timing and scheduling for minimal impact on clinic operations. Schedules driver training for all staff who may regularly drive mobile clinics and ensures Clemson Defensive Driving certificates are up to date for all regular drivers. Coordinates with unit vendors as needed. Serves as primary driver/operator for the assigned mobile health unit(s). Supports provider and clinical team with blood draws and other clinical tasks (within license scope).

35% - Essential - Delivery of lifestyle / health education:

Develops, coordinates, disseminates lifestyle/health education under the supervision of a licensed healthcare provider with a focus on chronic disease management, with a primary focus on diabetes, but also including hypertension, cancer, obesity, congestive heart failure, and COPD. Lifestyle education may involve one on one or group education with topics related to nutrition, physical activity and behavior change. Monitors SDOH factors affecting health and assists patients with goal setting to achieve behavior change. Accurately documents in electronic health record. Utilizes electronic health record reporting tools to monitor patient outcomes and modify programs as needed.

15% - Essential - Facilitation of patient/group activity through technology:

Responsible for inputting patient level data into electronic health record and other platforms (e.g., MyChart, Carium). Responsible for registering patients, documenting progress, and connecting with

clinicians as necessary. Facilitates use of telehealth platforms and mobile health solutions in support of lifestyle education. Utilizes appropriate technology to recruit, track and communicate with patients, including social media. Assists clinicians with remote patient monitoring of chronic disease.

15% - Essential - Conduct outreach and assists in building community collaborations: Serves as link between community resources and patients to improve health and well-being of communities at large. Serve as liaison between clinicians and community resources.

Minimum Requirements:

Education - High School Diploma or Equivalent and experience or training within the specific work area; Work Exp 1+ years in clinical or pre-hospitalization care; experience driving medical units; Licenses - Drivers License Class D normal < 26,000.

Preferred Requirements:

Certifications - EMT-PARAMEDIC; Work Exp 3+ years working in prehospital care and/or with clinics; Current state/national registered certification as paramedic; current BCLS; current ACLS.
